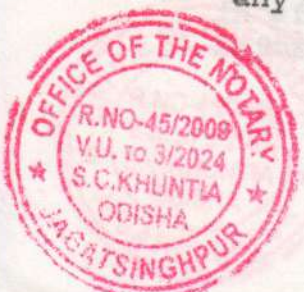

7. That the Principal and Correspondent / Manager of the school have individually gone through the ~~previous~~ provisions contained the affiliation & examination bye laws and the circulars issued by the Board from time to time . The school undertakes to abide by the provisions contained in the affiliation & examination byelaws , directions issued from time to time and the law of the land .







